



Nuneaton Town Supporters Co-Operative 200 Club Rules

- 1) The name of the draw is the 200 Club ("the Lottery") regardless of the number of shares.
- 2) The purpose of the lottery is to raise funds for Nuneaton Town Supporters' Co-operative and Nuneaton Town FC.
- 3) The Lottery will be administered by an organiser appointed by the board of Nuneaton Town Supporters' Co-operative.
- 4) 50% of the total monthly subscriptions will be paid out in the form of prizes. The prize fund will be split as follows 50%, 30%, 15%, and 5%.

Prizes will be set on a pro rata basis of the actual numbers of participants at the time of each draw.

The Lottery shall run from August of any year to the following July.

- 5) The Lottery will be open to anybody aged 16 or over.

A purchaser of a share becomes a participant in the Lottery.

Participants are entitled to hold any number of shares.

- 6) The number of shares in the Lottery shall be unlimited and each share shall be allocated a membership card with their unique number. Tickets however will not be issued.
- 7) The subscription for each share is £10 per month.

All participants must pay in advance by either; an upfront payment of £120 by cash, Paypal or cheque (made payable to Nuneaton Town Supporters Co-Op 200); a monthly standing order mandate; monthly Paypal payment; or monthly cash payment.

Participants sign up for a 12 month commitment (it is acceptable to join part way through the year), however, if the participant misses two payments in a row their number is withdrawn and re allocated. Participants can only win once per number per draw.

- 8) There shall be a draw made in each calendar month.

All participants are entitled to attend the draws, which must be held in the presence of at least 3 members of the Supporters Co-Op on such occasions and times as the organiser shall deem appropriate.

Prize winning numbers will be drawn at random.

- 9) Winners will be paid by cheque, which will be delivered to the last known address held by the promoter. It is the responsibility of the participant to advise the organiser of any change of address. Any prize cheque not cashed within 6 months will be deemed a donation to the Co-op.

- 10) The Promoter will not pay a prize to any Participant other than the purchaser of the winning shares.

- 11) No Lottery participant will be included in the draw if the subscription has not been received. It is the responsibility of each Participant to make sure they have paid their subscription. The organiser reserves the right to reallocate any number where payment has not been received.

- 12) Participants can cancel their entry in the Lottery at any time. Any decision by the Co-op to end the lottery will also be by one month's notice to all participants.

- 13) Under no circumstances can subscriptions be refunded.

- 14) The organiser will determine any dispute.

An appeal may be made to the Supporters' Co-Operative whose decision shall be final.

- 15) The Lottery is intended to be a private lottery under the provisions of the Gambling Act 2005 Section 14.

- 16) Nuneaton Town Supporters' Co-Operative may amend or vary the rules of the lottery at any time.
